



# **Energizing Investigations in the Energy Sector**

## **Client Challenge**

Our client, a global leader in the oil and gas industry, continually faced internal threat investigation requirements across multiple divisions and departments. These investigation requirements, ranging from internal fraud and theft to employ misconduct, became increasingly challenging for the client to address given the growing volumes of employee work product to be considered, the disparateness of data formats and systems, and the accelerating need to be able to make preliminary post-incident risk assessments within hours of incident identification.

Routinely needing to perform investigations on activities and events within hours and days (not weeks) to maximize risk mitigation, the client sought to transition from a highly manual investigation workflow using first-generation investigation technology to a highly automated workflow using the latest generation of automated investigation technology. Also, the client sought a cloud-based solution that would allow remote access from remote geographic areas and remove any burden on their internal network access without sacrificing data security. Finally, the client sought an investigation capability that would efficiently support and integrate with existing workflows and downstream compliance and legal discovery practices.

### **CloudNine Solution**

The solution, CloudNine's simplified investigation automation technology, a SaaS-delivered, web-accessible, full-featured investigation review platform that enables users to upload and process data from any remote location immediately and begin advanced searching and reviewing of data within a couple of hours, was selected after the client completed their vendor evaluation and due diligence process. The client based their selection of CloudNine on the three primary factors of *ability, flexibility,* and *security*.

This speed allowed the company to make prompt, time-sensitive decisions that directly impacted the financial and operational integrity of the enterprise.
