





CloudNine Discovery Definitions

Data Discovery is the exploration of patterns and trends within unstructured data with the objective of uncovering insight and driving action.

Electronic Discovery (Legal Discovery) is the process of identifying, preserving, collecting, processing, searching, reviewing and producing electronically stored information that may be relevant to a civil, criminal, or regulatory matter.


Trigger Events are actions that trigger an organization's legal duty to preserve data. They can occur at any point in the information lifecycle, typically are the starting point for legal discovery, and may be the starting point for the litigation lifecycle.

Unstructured Data is content that does not conform to a specific, pre-defined data model. It tends to be the human-generated and people-oriented content that does not fit neatly into database tables.


Legal Discovery

Full Text and Metadata Indexing occurs on each endpoint and the indexes are updated regularly and stored in place on each endpoint.



Indexed information is managed systematically at the Data Discovery Command Console. The Command Console then allows administrators to **search** across all endpoint indexes simultaneously for keywords, metadata, and patterns.





Based on analysis and decision criteria, files can be **preserved**, and, as required, **collected**.



Ingestion and **processing** automation allow users to upload data into a secure online repository in a private and protected cloud environment and have that data automatically converted into a usable format for review.



Review automation allows users to utilize advanced analytics and technologyassisted review to assess, review, and analyze data.




Production automation gives users the ability to create precision productions and privilege logs that are exportable into almost any form.
